Call for application for the selection of no. 15 students to attend the Afya Moja Summer School 2025 organised by the Polythecnic University of Bari, in collaboration with other Italian Afya Moja Partners Institutions Università Campus Bio-Medico di Roma, Università degli Studi di Napoli Federico II, Università di Pisa and Alma Mater Studiorum – Università di Bologna.

Art.1 - Training activities

The Summer School will be held at Ostuni from 21 to 25 July 2025 (5 working days) and aims to provide in-depth training and offer an interdisciplinary perspective on the issues of One Health paradigm, integrating human, animal, and environmental health.

Teaching will take place through a combination of theoretical lectures and interactive group work sessions and case studies. All the lectures will be delivered in English by international experts and professors specialized in various aspects of One Health.

Art.2 - Rules of participation

Attendance in person is required.

Art.3 - Eligible students

The call is addressed to students enrolled in a **master's or doctoral degree** in disciplines related to One Health, including engineering, computer science, maths, physics, medicine, or veterinary, biological and/or environmental studies, at African Universities that are associated partners of the project "TNE AFYA MOJA - Health Technology: from capacity building to capacity strengthening" and have an active Memorandum of Understanding with the Afya Moja Partners. Participation in the Summer School is restricted to a maximum number of **15 students**. The selection will be based on the overall assessment of the submitted documents and is entrusted to the Summer School Scientific Committee. The results of the selection will be published on the Polytechnic of Bari and AFYA MOJA project websites and communicated by e-mail.

Art.5 - Selection and participation grant

The selection of the winners will be based on merit criteria at the sole discretion of the Scientific Committee of the Summer School. The expenses for the participation in the Summer School of students from African Universities associated partners (Art. 3) will be covered by the TNE AFYA MOJA project, including course, accommodation and travel. Further details will be communicated to the selected participants.
